





Statistics contained within this report include adult and juvenile victims.



Domestic Violence – 2010

- Of the **18,239** violent offenses* reported in 2010, **12%** were domestic violence incidents. Domestic violence was indicated in **2,193** offenses reported: in **36** homicides; **187** rapes; **52** robberies; and in **1,918** aggravated assaults. **1,031** incidents of domestic violence were cleared for a **47%** clearance rate. **39%** of the clearances were exceptional, i.e. lack of prosecution.
- There were **27,470** domestic simple assaults, which represent **36%** of all simple assaults reported in 2010. **12,648** domestic simple assaults were cleared for a **46%** clearance rate. **43%** of the clearances were exceptional.
- 75%** of the victims were females, and **25%** were males. **54%** of the victims were black, and **46%** were white. In **58%** of the offenses, the offender was black, and in **75%** the offender was male.
- A firearm was the weapon used in **19%** of the offenses; hands, fists or feet were used as a weapon in **46%**; a knife was the weapon used in **18%**; and other dangerous weapons were used in **17%**.
- 52%** of the victims suffered injuries: **10%** were injured with a firearm; **21%** were injured with a knife; **51%** were injured with fists, hands or feet; and **18%** were injured with other dangerous weapons.
- In **23%** of domestic violence offenses the victim was the wife/ex-wife of the offender; in **42%** the victim was the girlfriend/ex-girlfriend of the offender.





Domestic Violence – Assault

Aggravated

- Of the **12,157** aggravated assaults reported in 2010, **1,918** were domestic aggravated assaults - or **16%** of all aggravated assaults reported in Alabama for that year. **908** incidents of domestic aggravated assault were cleared for a **47%** clearance rate. **37%** of the clearances were exceptional.
- A firearm was the weapon used in **20%** of the assaults; hands, fists or feet were used as a weapon in **43%**; a knife was the weapon used in **19%**; and other dangerous weapons were used in **17%**.
- **54%** of the victims were injured: **9%** with a firearm; **22%** with a knife; **51%** with hands, fists or feet; and **18%** with other dangerous weapons.
- **23%** of the victims were a wife or ex-wife of the offender; **40%** of the victims were a girlfriend or ex-girlfriend of the offender; and **13%** of the victims were a husband or ex-husband of the offender. **59%** of the offenders were black, and **73%** were males.


Simple

- There were **27,470** domestic simple assaults reported in 2010, or **36%** of all simple assaults for that year. **12,648** incidents of domestic simple assaults were cleared for a **46%** clearance rate. **43%** of the clearances were exceptional, i.e. lack of prosecution.
- Hands, fists, feet or voice were used as a weapon in **88%** of these assaults, however, **40%** of the victims still reported injuries.
- **30%** of the victims were a wife or ex-wife to the offender; **45%** were a girlfriend or ex-girlfriend.


Domestic Violence - Homicide

- There were **36** domestic homicides reported in 2010, representing **14%** of the **255** homicides reported in Alabama for that year. **25** domestic homicides were cleared for a **69%** clearance rate.
- **39%** of the victims were males, and **61%** were females. **58%** of the victims were black, and **42%** were white.
- A firearm was the weapon used in **64%** of the homicides; a knife was the weapon used **25%**; hands, fists or feet were used as a weapon in **8%**; and other dangerous weapons were used in **3%**.
- In **37%** of the homicides the victim was the wife or ex-wife of the offender; in **22%** the victim was the husband or ex-husband; in **14%** the victim was the girlfriend or ex-girlfriend; and in **27%** of the homicides the victim was the boyfriend or ex-boyfriend of the offender.
- **69%** of the homicides occurred at a residence; **8%** occurred in a highway, street or alley; and **23%** occurred in other locations.
- In **61%** of the homicides the offender was black; and in **65%** the offender was a male. **61%** of the homicides had black victims and black offenders; **36%** had white victims and white offenders; **0%** had white victims and black offenders; and **3%** had black victims and white offenders.


Domestic Violence - Robbery

- There were **52** robberies in 2010 that indicated domestic violence. This represents **1%** of the **4,579** robberies reported for Alabama in that year. **21** domestic robberies were cleared for a **40%** clearance rate. **62%** of the clearances were exceptional.
- A firearm was the weapon used in **20%** of the robberies; hands, fists or feet were used as a weapon in **67%**; a knife was the weapon used in **4%**; and other dangerous weapons were used in **9%**.
- **28%** of the victims suffered injuries: **17%** were injured with a firearm; **0%** were injured with a knife; **75%** were injured with fists, feet or hands; and **8%** were injured with other dangerous weapons.
- **73%** of the victims were the girlfriend or ex-girlfriend of the offender; **8%** of the victims were the wife or ex-wife of the offender.
- **46%** of the offenses occurred at a residence; **19%** occurred in a street or alley; and **35%** occurred in other locations.
- In **72%** of the robberies, the offender was black and in **86%** the offender was a male.

Domestic Violence - Rape

- There were **187** domestic violence rapes in 2010, representing **15%** of the **1,248** rapes reported in Alabama for that year. **77** domestic rapes were cleared for a **41%** clearance rate. **62%** of the clearances were exceptional.
- **34%** of the victims were black females and **66%** were white females.
- A firearm was the weapon used in **6%** of the rapes; hands, fists, or feet were used as a weapon in **76%**; a knife was the weapon used in **3%**; and other dangerous weapons were used in **15%**.
- **29%** of the victims suffered injuries: **8%** were injured with a firearm; **8%** were injured with a knife; **78%** were injured with fists, feet or hands; and **6%** were injured with other dangerous weapons.
- **83%** of the victims were the girlfriend or ex-girlfriend of the offender, and **17%** of the victims were the wife or ex-wife of the offender.
- **76%** of the offenses occurred at a residence; **4%** occurred in a street or alley; and **20%** occurred in other locations.
- In **55%** of the rapes the offender was white, and in **45%** the offender was black.
- **30%** of domestic rape victims were juveniles, but only **10%** of the offenders were juveniles.
