

ALABAMA MARINE POLICE MARINE SANITATION DEVICE (MSD) INSPECTIONS SPECIAL AGENT AGREEMENT

The State of Alabama, Department of Conservation and Natural Resources, Marine Police Division, hereinafter referred to as "DCNR" and the undersigned person, hereinafter referred to as "Agent", for and in consideration of the terms and conditions contained herein, hereby agree as follows:

- 1. DCNR grants permission to Agent to serve as a Special Agent for the purpose of conducting marine sanitation device (MSD) inspections for DCNR, in accordance with the attached Rule No. 220-6-.61-.164ER, as well as the permanent rule adopted as Rule No. 220-6-.61, and any amendments thereto which may occur from time to time in the future.**
- 2. Agent understands and agrees that this permission does not in any way confer any law enforcement powers on Agent.**
- 3. Agent agrees to comply with all rules and regulations, as well as any DCNR policies and procedures regarding the conducting of inspections, charging of fees, remittance of amounts to DCNR, or any other matters relating to this agreement.**
- 4. All remittances from Agent to DCNR shall be in the form of a check or money order, made payable to the "State of Alabama, Department of Conservation and Natural Resources, Marine Police Division". If any check is returned, the Agent will be subject to a \$30.00 service fee or charge. In addition, Agent agrees to obtain and provide to DCNR the original of a payment bond, issued by a company licensed in Alabama to issue same, in form satisfactory to DCNR, guaranteeing payment to DCNR of amounts owed to it, up to a \$10,000 indemnity. The "payee" listed on the bond shall be in the name of "State of Alabama, Department of Conservation and Natural Resources, Marine Police Division."**
- 5. Agent understands and agrees that failure to comply with all terms and conditions of this agreement may result in the immediate termination of this agreement and the permission to serve as Agent.**
- 6. In the event of the expiration or termination of this agreement for any reason, Agent shall immediately remit to DCNR any and all amounts due to be paid DCNR, as well as any and all records, books, decals, ledgers, and any other paperwork or records of any type, relating to Agent's duties under this agreement.**
- 7. This agreement is not assignable or transferable, without the express written authorization of DCNR.**
